<p><b>Stakeholders:</b> The Port Authority in coordination with the Government / Municipalities</p> <p><b>Legal Framework:</b> Country A counts with the Environmental Protection (Pollution from Plastics) Regulations from 2020, as a measure to reduce the waste generated by single-use disposable plastics at source by restricting their entry into the system and planned phase-out of single-use plastics and 'styrofoam'.</p> <p><b>Recommendation/Orientation:</b> Local PROMAR experts conduct meetings with the port authority and create a team to sign agreements on 30% plastic reduction and draft procedures to ban single-use plastic and styrofoam in all the ports. Supply the port management and purchase department with information on eco-friendly products and their producers where to get the alternative biodegradable products (Example: "Friends of Ecology" Pvt. Ltd.), calculate the costs for replacement and report to the management of the port authority.</p> <p><b>Monitoring:</b> Local PROMAR Experts monitor the number of products replaced with the help of the purchase list.</p>
